

SEASIDE TATTOO SHOW

ARTIST & VENDOR REGISTRATION

The 3rd Annual Seaside Tattoo Show is scheduled to be held at the Ventura County Fairgrounds in beautiful Ventura, California. This years event takes place March 8th-10th, 2019.

The cost of each 10x10 booth includes the pipe/drape, tables, chairs, electric outlets and electricity, 2 trash cans, a sharps container, event parking passes, and 4 weekend passes to the event. Additional weekend passes may be purchased at check-in for \$20.00. **NOTE: Do not send ONE check for ALL FEES. Health fees must be paid separately. ALL FEES must be paid in full by February 1st, 2019.**

To reserve your booth, complete the enclosed registration and health forms and return with full payment – Venmo, credit card, cashiers checks and money orders – are acceptable forms of payment. United States Funds Only. Checks are payable to: Christina Diaz. 50% of Booth Fee is required to reserve space. ALL SALES ARE FINAL. No refunds. No exceptions.

Each practitioner must provide a copy of your current Blood Borne Pathogen Certificate, Hep C declination form, along with current County Health Registration in your county/State and a photo copy of your ID.

HEALTH FEES: In addition to the Convention Booth Rate, the Ventura County Environmental Health Department also has 2 separate fees. The first is a Practitioner Fee of \$168.45 – if you are registered in Ventura or LA County this fee is waived. Each artist must still send in all required paperwork listed above. For example, if you are currently registered in Sonoma County (in CA) or if you are registered in say Portland, Oregon – instead of paying the \$168 to Ventura EHD, you can pay \$54 and register in LA County. It's cheaper and a much easier process. I know it's a pain in the ass, but it's the smartest thing to do so do not wait until the last minute. Second health fee is the "Event Booth Fee" of \$252.68, this fee is paid per SHOP, not per booth. So if you get 1 booth or if you get 3 booths – you pay the same price. **It's a fee per shop**, so you can split that amongst all the artists in the booth.

NOTE: Do not send ONE check for ALL FEES. Health fees must be paid separately. The Health Department will only accept cashiers checks/money orders payable to EHD.

TERMS & CONDITIONS

- 1) No colors policy strictly enforced. No weapons or hate-related materials allowed.
- 2) No animals allowed in exhibition hall. No exceptions. It's against health code.
- 3) We will provide a photocopier, thermal fax at the Info Booth for your convenience. We will also provide each booth with a sharps container (one container = 2 artists).
- 4) All booths must be manned at all times during convention hours. All booths should be open and ready for business according to the times listed below. The San Miguel Hall will be open to the public at the times listed below. Hall will be locked and cleared 15 minutes after event has ended. No exceptions. Please judge yourself accordingly and leave a reasonable amount of time to finish any work in progress.

- 4) Exhibitor Set-Up listed above on Friday, March 8th ONLY. Exhibitors are responsible for all other materials that they deem necessary to conduct business i.e. extra lighting, mounting hardware for banners or signs, extension cords, paper towels, distilled water, consent forms, etc.
- 5) All needles must be disposed of in the provided sharps container. On Sunday, please leave your sealed sharps container at the front of your table for proper disposal.
- 6) Body piercing of the genitals or nipples must be screened from public view. If you plan to offer this service, you are obligated to provide a screen for such purposes.
- 7) All business transactions and liabilities associated with those transactions are the sole responsibility of the Exhibitor and/or customer involved.
- 8) All practitioners must have consent forms for all clients. Aftercare forms are also required for both tattooers and piercers so be sure to bring those with you. This is a requirement by the health department.

In signing this contract, I have read, understand, and agree to comply to all terms stated herein. Failure to comply is grounds for dismissal from event. No refund shall be given under such circumstances. Exhibitor and its agents, employees and representatives will at all times comply with all Federal, State, County, Civic and Local laws and ordinances. Exhibitor shall be responsible for obtaining any and all licenses, permits, or approvals required under State and Local laws applicable to Exhibitor's particular activity. The Exhibitor agrees to hold harmless Christina Diaz, Seaside Tattoo Show, the Ventura County Fairgrounds, and any agent, employee or representative affiliated with any and all types of liability, loss, damage, injury, accidents, fire, theft, natural disasters or acts of God, arising directly or indirectly from said event. Christina Diaz and Seaside Tattoo Show makes no representation or warranty regarding the success of the show, including by not limited to, attendance, Exhibitor participation, weather or success of Exhibitor's booth.
