

4th SEASIDE TATTOO SHOW

ARTIST & VENDOR REGISTRATION

The 4th Annual Seaside Tattoo Show is scheduled to take place on September 11-13th, 2020 in the San Miguel Hall at the Ventura County Fairgrounds in Ventura, California.

The cost of each artist booth includes the pipe/drape, tables, chairs, electric outlets and electricity, 2 trash cans, a sharps container, event parking passes, and 4 weekend passes to the event. Additional weekend passes may be purchased at check-in for \$20.00, this price is available for pre-registration only. Vendor booths have all of the above except the sharps containers.

Each Body Art Practitioner must each provide the following:

1. Copy of your current Blood Borne Pathogens Training Certificate *(must be from an "Approved Provider" – see Seaside website for that approved list).*
2. Copy of your current County EHD License in your County/State of California. *(additional fee applies if you are not located in the state of California).*
3. Documentation of Hep B Vaccination
4. Copy of your photo ID.

HEALTH FEES: In addition to the Artist Booth price, the Environmental Health Department (EHD) has a "Event Booth Fee" of **\$86.23**, this fee is paid PER SHOP, not per booth. So if you get 1 booth or if you get 3 booths – you pay the flat \$86.23 fee. It's a fee per shop, so you can split that amongst all the artists in the booth. **Artist Booth and Health fees must be PAID SEPARATELY: Please do not send one big check. It will not be accepted. Health fees ONLY accepted in cashiers check or money orders payable to: EHD. ALL FEES must be paid in full by August 10th, 2020. Health fees no later than August 7th, 2020.**

To reserve your artist booth: 1) Complete the enclosed registration form on Page three. 2) Submit required County Health Department paperwork per Practitioner (listed above) 3) Payment for EHD in check or money order. 4) Payment for Artist Booth – Venmo, Pay Pal, cashiers check, money order, or credit card 3.5% fee applies, are all acceptable forms of payment. **United States Funds Only. Seaside Payments are payable to: Christina Diaz. 50% of Booth Fee is required to reserve space. ALL SALES ARE FINAL. NO REFUNDS. NO EXCEPTIONS.**

TERMS & CONDITIONS

- 1) No colors policy strictly enforced. No weapons or hate-related materials allowed.
- 2) No animals allowed in exhibition hall. No exceptions, it is against County Health Code.
- 3) We will provide a photocopier, thermal fax at the **Info Booth** during the event for your convenience. We will also provide each booth with a sharps container (one container = 2 artists).
- 4) All booths must be manned at all times during convention hours. All booths should be open and ready for business according to the times listed below. San Miguel Hall will be open to the public at the times listed below. Hall will be locked and cleared 15 minutes after event has ended. Please judge yourself accordingly and leave a reasonable amount of time to finish any work in progress. No exceptions.

- 5) Exhibitor Set-Up listed above on Friday, September 11th ONLY. Exhibitors are responsible for all other materials that they deem necessary to conduct business i.e. extra lighting, mounting hardware or S-hooks for banners or signs, extension cords, paper towels, distilled water, consent forms, etc.
- 6) All needles must be disposed of in the provided sharps container. On Sunday, please leave your sealed sharps container at the front of your table for proper disposal.
- 7) There is a \$30 minimum for all body piercings. Body piercing of the genitals or nipples must be screened from public view. If you plan to offer this service, you are obligated to provide a screen for such purposes.
- 8) All business transactions and liabilities associated with those transactions are the sole responsibility of the Exhibitor and/or customer involved.
- 9) Practitioners must use Consent Forms per Body Art Procedure. Aftercare forms are also required by all Body Art Practitioners. This is required by Ventura EHD. Copies will be available at all times during the show at the **Info Booth** for your convenience.
- 10) No Music allowed in booths. It conflicts with Event DJ. Bring earbuds.

In signing this contract, I have read, understand, and agree to comply to all terms stated herein. Failure to comply is grounds for dismissal from event. No refund shall be given under such circumstances. Exhibitor and its agents, employees and representatives will at all times comply with all Federal, State, County, Civic and Local laws and ordinances. Exhibitor shall be responsible for obtaining any and all licenses, permits, or approvals required under State and Local laws applicable to Exhibitor's particular activity. The Exhibitor agrees to hold harmless Christina Diaz, Seaside Tattoo Show, the Ventura County Fairgrounds, and any agent, employee or representative affiliated with any and all types of liability, loss, damage, injury, accidents, fire, theft, natural disasters or acts of God, arising directly or indirectly from said event.
